## 7. Lydiard Millicent Neighbourhood Plan – Pre-submission Consultation and Publicity

Appendix C

Members are asked to consider the attached Neighbourhood Development Plan for the parish. A group, consisting of councillors and residents, have consulted throughout the parish to produce this Neighbourhood Plan which will, eventually, be a legal document appended to Wiltshire Council planning policies. The document sets out the vision for Lydiard Millicent Parish until 2036, detailing what development would be acceptable and how ideally it is managed.

During the process of compiling this plan there are a number of formal stages to be completed prior to adoption by Wiltshire Council. One of those formal stages has now been reached; the Neighbourhood Plan Steering Group will present their plan for adoption by the Parish Council, so they can continue with Regulation 14, which is a six week pre-submission consultation and publicity for the plan.

As the qualifying body, members will be asked to consider this information and approve adoption of this report.

#### 9. Annual Estimates of Income and Expenditure

Appendix E

Councillors are advised that the effect of section 106 of the Local Government Finance Act 1992 is that if, when considering budgetary items, any Councillor is in arrears for more than two months with his/her Council Tax, he/she must declare that section 106 of the Local Government Finance Act 1992 applies and neither speak nor vote on the matter before Council. Failure to observe this renders the Councillor liable for prosecution by the Director of Public Prosecutions.

It is the responsibility of the Parish Council to levy a precept on Wiltshire Council to cover its costs for the following financial year; this levy can only be demanded once in any year. Wiltshire Council is the charging authority and will collect this on behalf of the Parish Council. Details for the 2019/20 financial year must be with Wiltshire Council no later than 25th January 2019.

In order for a precept to be levied the Council must first set a budget; details of the draft budget is attached. The Council will be asked to consider its budgetary requirements for 2019-20 and then decide on the precept it wishes to levy. It should also be noted that there will not be a cap on increases to Parish Council taxes for the next two years; the Government will review the situation again hopefully before 2021-22 budgets are prepared.

The Council is asked to consider the proposed draft budget report and to state the amount of tax to be collected on its behalf by Wiltshire Council.

#### 10. Establishment Levels
